sections as indicated hereunder:-

The recognition is accorded subject to the following
conditions:-

1. The strength of students in a language subject should be
not less than 10 and in non-language subjects 15 and in each
section of I Year P.U.C. the strength should be atleast 40
students and not exceeding 90 students throughout the
academic year.

2. The Principal and the other teaching staff teaching Pre-
University Education Classes should have qualifications as
prescribed in the staff pattern of Junior Colleges and the
Principal should also look after the High School Classes.

3. Rs. 2000/- being the first instalment of stability fund of
Rs. 10,000/- (to be deposited in five equal yearly instalments)
should be deposited in the fixed deposit in Joint names of the
management and of the Director, Pre-University Education,
Bangalore and the F.D.R. should be sent to this office for
safe custody.

4. The library of the Junior College should be equipped with
10,000 volumes as per rules.

6. The norms for Junior Colleges prescribed by Board of Pre-University Education should be followed strictly.
7. The administrative approval of the Director Public Instruction should also be obtained in this behalf as your institution is a composite Junior College and comes under the jurisdiction of this office.

7) The staff over 60 years of age should be replaced forthwith.
